To Whom It May Concern:

T-Mobile USA, Inc., ("T-Mobile") is in receipt of your correspondence dated January 26, 2026, regarding the above-referenced account.

T-Mobile regrets any concerns [REDACTED] may have experienced regarding their Mobile Device Unlock request, and we appreciate the opportunity to respond. The account was activated on January 17, 2026, with one voice line ending in [REDACTED]. This line was subscribed to our *Essentials Saver* rate plan billed at \$55.00 per month, plus applicable taxes and fees. At the time of activation, [REDACTED] used our Equipment Installment Plan (EIP) to purchase a Motorola moto g power handset at the retail price of \$88.00. [REDACTED] remitted a down payment of \$40.00 and agreed to 24 monthly installments of \$2.00.

On January 22, 2026, [REDACTED] remitted a payment for the remaining EIP balance. T-Mobile records indicate, on this date [REDACTED] contacted T-Mobile's Customer Care to request a Mobile Device Unlock. Please note, Mobile Device Unlocks are available for those devices that meet our eligibility requirements. The Mobile Device Unlock requirements can be located on our website at <https://www.t-mobile.com/responsibility/consumer-info/policies/sim-unlock-policy>. These requirements include, but are not limited to:

- The handset must be purchased from T-Mobile or an authorized third-party vendor and branded for use on the T-Mobile network.
- The device must be paid for in full.
- The account must be in good standing.
- The device must be utilized on the T-Mobile network for 40 days.

As the Motorola moto g power handset had not been in use on the network for 40 days, it was not eligible for a Mobile Device Unlock.

T-Mobile contacted [REDACTED] on January 28, 2026, and advised them of the above information. To resolve this matter, T-Mobile completed a Mobile Device Unlock for the Motorola moto g power handset. T-Mobile regrets any inconvenience to [REDACTED].
